



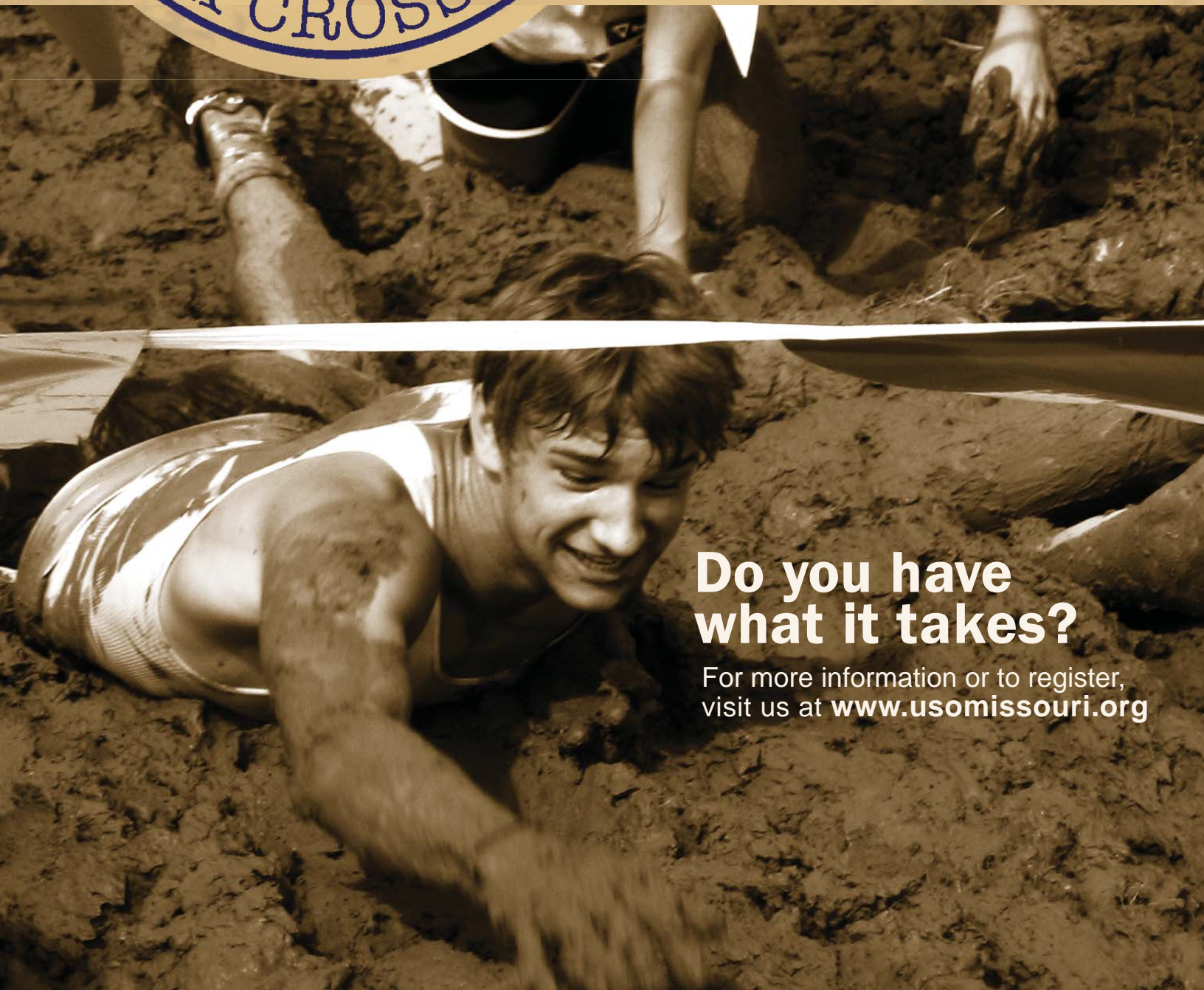

### HOLD HARMLESS AGREEMENT
